# Update from the Secretariat

#### DR ALPHONSUS AIGBIREMOLEN

The national secretariat of APHPN has continued to actively discharge its functions in promoting the ideals of APHPN and supporting state branches in their activities. Highlights of activities carried out within the fourth quarter of 2021 were:

The President, Prof. Alphonsus Isara led a team of APHPN members to participate in the funeral ceremonies of Late Justice Samuel Oseji, husband of Dr. Mininim Oseji at Asaba, Delta State on the 11th of November 2021.

The President, Prof. Alphonsus Isara, the National Treasurer, Dr Adesuwa Aigbokhaode, and members of the Delta State branch of APHPN paid a courtesy visit to the Permanent Secretary of Delta State Primary Health Care Development Agency, Dr Jude Winful-Orieke. The visit provided an opportunity to discuss the necessity and mutual benefits of continued collaboration between the Agency and APHPN.

The Health Care in Danger Working Group (HCiD WG), a collaborative network between APHPN and ICRC, was inaugurated in November 2021. Prof. G. K. Osagbemi leads the Group with members spread across Nigeria. The HCiD project is envisioned to promote the mainstreaming of violence and healthcare into the undergraduate and postgraduate medical curriculum in Nigeria.

The APHPN President visited the ICRC Office in Abuja on the 17th of November 2021. He had an interactive session with the ICRC Head of HCiD Initiative Geneva, Maciej Polkowski, the Head of Prevention, ICRC Abuja Delegation, Leonard Blazeby and the HCiD Advisor for the ICRC, Dr. Ryan Enaworu.

In November 2021, the President participated in the APHPN Lagos State Biennial Scientific Conference. The President gave a goodwill message during the conference which was themed "PANDEMICS AND EMERGENCY PREPAREDNESS: BEYOND COVID-19"

## Public Health Spotlight

# Primary Health Care in Nigeria: progress and challenges towards the achievement of Universal Health Coverage

Primary health care (PHC), as conceptualized by the Alma Ata declaration of 1978 is a grass-roots approach towards universal and equitable health care for all. It is the "first level of contact with the National Health System"; bringing health care as close as possible to where people live and work, and constitutes the first element of the continuing health care process. Primary Health Care is indeed the "first point of access to health care by individuals, families, and communities". It is thus described as the bedrock of Universal Health Coverage. It was adopted as the cornerstone for the actualization of the health for all strategy and an improved health system in Nigeria in 1988. But prior to the 1978 Alma-Ata declaration and the launching of the National Health Policy, Nigeria had implemented the Basic Health Services Scheme (1975-1980). This strategy, which was also grass-roots oriented, failed to engender community participation and ownership of health programmes. Beyond the Alma-Ata mandate of PHC, it has been transformed and strengthened since its adoption in Nigeria. There were landmark achievements in immunization coverage and uptake of exclusive breastfeeding across the country in the late 80s.

The initial efforts towards the improvement of Primary health care delivery in Nigeria included the strengthening of community participation through the Bamako initiative programme and the establishment of the National Primary Health Care Development Agency in 1987 and 1992 respectively. Achievement of Universal Health Coverage in Nigeria is primarily tied to the progress made in its implementation of PHC.

Universal Health Coverage (UHC) is defined as the ability of all people who need health services to receive them without incurring financial hardship, thereby achieving equity and access. It can only be achieved with the existence of a well-functioning health system and timely access to services.

Within the context of the National Health System of Nigeria, the National Health Policy identifies PHC as the cornerstone in the achievement of UHC. Over the years, some of the initiatives which have been deployed by the Federal Government of Nigeria, towards the attainment of the UHC through PHC include the "Revitalization of PHC initiative; Midwifery Service Scheme (MSS). Maternal Neonatal and Child Health (MNCH) Week, Strengthening of NHMIS, Quarterly PHC Reviews and the introduction of PHC Under One Roof (PHCUOR).

The 56th National Council on Health (NCH) in 2011 adopted Primary Health Care Under One Roof (PHCUOR) as a national policy to improve the implementation of PHC. In addition, the 58th NCH in 2013 adopted the PHCUOR implementation guidelines as a tool towards the realization of effective national implementation of the strategy. The concept of PHCUOR combines the Principle of "Three Ones": One Plan; One Management and One Monitoring and Evaluation System.




Figure 1: Distribution of the Basic Healthcare Provision Fund in Nigeria

Furthermore, the National Health Act (NHAct) of 2014 outlines the major steps towards the achievement of UHC using PHC. It clearly defines the various modalities of funding the health care system. It stipulates fund disbursement through three payment gateways from the Basic Healthcare Provision Fund (BHCPF). The BHCPF is derived from one per cent (1%) of the Consolidated Federal Revenue. Forty-five per cent of the fund is to be remitted to the National Primary Health Care Development Agency (NPHCDA); five per cent is remitted to the Federal Ministry of Health (FMOH) for emergency medical treatment. In addition, 50% of the fund is allocated to the National Health Insurance Scheme: which is used for the Basic Minimum Package of Health Services (BMPHS). It is envisaged that the BMPHS can be expanded as Government revenues grow. It is indeed meant to be implemented in phases to the population.

#### **Challenges:**

Some of the major challenges with the implementation of PHC across Nigeria include: (i) poor Infrastructure – about 30,000 public primary health facilities have been reported to be dilapidated; Fragmentation (ii) in governance coordination. Human resources for primary health care in various states are still under the Local Government Service Commission, contrary to the guidelines of PHCUOR; (iii) Poor funding - evidenced in programmes/interventions being largely donor dependent; (iv) Shortage of Human Resource for Health; (v) lack/non-functional equipment; (vi) Poor demand for services largely driven by a loss of confidence in the system. Only 38% of pregnant women have been reported by a recent survey to have delivered under the supervision of skilled birth attendants; while 58% of pregnant women were reported to have received ANC in their last pregnancy; (vii) PHC caters for only about 20% of the entire population (in contrast to the expected care for about 80% of the population, thus significant burden transferred to secondary and tertiary level of care; (viii) Poor and unreliable data; (ix) Poor Community engagement and demand for PHC services.

## Measures that should be put in place by government to address these challenges include:

- i) Re-positioning of PHC through the new Health Reform Committee:
- (ii) Improve funding of health care, Health Tax Fund can be considered as additional measure to increase public funding for PHC;
- (iii) Reliance on out-of-pocket expenditure (OOPE) must decline with aggressive measures towards high level of financial protection through health insurance (insurance coverage towards UHC target of 90%);
- (iv) Fast track progress towards achieving UHC by upgrading PHC infrastructure;
- (v) Provision of adequate health workforce with incentives for those in rural locations;
- (vi) Lessons learnt from performancebased incentives need to be escalated and enshrined at all levels;
- (vii) Improve on quality of data leveraging on technology (ICT) to strengthen data management;
- (viii) All components of PHC to be emphasized as against the current focus on few of the components.

#### Conclusion:

PHC is a major backbone to achieving UHC in Nigeria. Several initiatives have been put in place to strengthen PHC in Nigeria but Nigeria is still a long way from achieving UHC. A lot is still required to strengthen PHC, if UHC is to be achieved. The new Health Sector Reform committee is another opportunity to put policies, initiatives strengthen PHC and also putting in effective and efficient implementation of programmes based on lessons learnt.

## Prof Obehi Okojie calls for health system strengthening and epidemic preparedness in Nigeria

The 2021 Faculty Day Lecture of the Faculty of Public Health & Community Medicine of the National Postgraduate Medical College of Nigeria was held on the 9th of August, 2021. The Faculty Day lecture titled "Exploring the Impact of COVID-19 on Communities and the Mitigation Efforts" was delivered by the distinguished and erudite scholar, Professor Obehi Okojie.

She highlighted that the COVID-19 pandemic has triggered an enormous impact on communities with a global surge in demand for health and social services; with some positive impact such as the boom in research output and global collaboration while bringing to the fore the very important role of public health and community medicine specialty.

Prof Obehi Okojie, in her conclusion stated that the COVID-19 pandemic has exposed the humongous deficiencies in the Nigerian health system including the social and welfare support for various communities. She calls attention to the need to sustain mitigation efforts that have been instituted and prepare for future pandemics as connected cycles while learning from the past ones.
