## UPDATE FROM THE SECRETARIAT

## Dr Alphonsus Aigbiremolen

Here are some important updates from the National Secretariat for the first quarter of 2023:

The 39th Annual General Meeting and Scientific Conference of APHPN was hosted by the Rivers State branch and held in Port Harcourt from 30th January to 3rd February 2023 with the theme Public Health Practice: New Opportunities and New Challenges. Apart from the AGM in which election of national Officers was conducted, other important and statutory meetings of the Association held during the conference. These include meetings of the National Executive Committee (NEC) and Board of Trustees (BOT).

Arising from deliberations of the 2023 Conference, members have been nominated into various committees of the Association and all committees were jointly inaugurated by the President, Prof. Alphonsus Isara, on the 22nd of February, 2023. Similarly, Chairmen and Secretaries of APHPN Caucuses have been duly appointed for period of 2023 to 2025.

Two Capacity Building Webinars made possible by the partnership between APHPN and World Continuing Education Alliance (WCEA) were held in the period under review. The January 2023 edition with the theme Evidence-based Public Health: Basics of Systematic Review and Meta-analysis was facilitated by Dr. Gregory A. Oko-oboh. Another webinar on Ethical Imperatives for Collaborative Research anchored by Prof. Zubairu Iliyasu was held in March, 2023. Both webinars had participants from across the globe.

Data collection for the ongoing APHPN and International Committee of the Red Cross (ICRC) nationwide study on Violence against Healthcare has been completed. The study is expected to provide evidence for the development of strategies to mitigate the rising number of cases of violence against healthcare in Nigeria and beyond.

# PUBLIC HEALTH SPOTLIGHT ONE HEALTH IN NIGERIA: PROGRESS, CHALLENGES AND WAYS FORWARD

Following the interaction between human and animal populations, it is important to note that some rodents, birds, and other animals can easily adapt to anthropogenic environments, which can be attractive due to food waste and other favourable conditions, acting as reservoirs of organisms with the potential to cause diseases among animals.1 Potentially, different risk factors such as poor housing situation, inappropriate garbage accumulation, and unregulated community growth can significantly aggravate this situation.1 Several other injuries from contact with animals continue to pose a significant public health problem globally.1 The improvement in technologies and policies for ecologically sustainable agriculture and improve food security minimizes impacts and can result in adequate supply and equitable distribution of food.2

The health risks associated with genetically modified organisms, chemical substances, pesticides, prion diseases and other microorganisms, which represent potential risks to human health may be transmitted by the consumption of contaminated food.3 The utilization of non-therapeutic chemicals and drugs in animals as an approach to increase production, which is associated with the emerging resistance of human pathogens to various antibiotics,4 resulting in increased suffering in the affected people and animals, has significant economic and social consequences because of the costs of treatment with social effects.5 These signify the need for global and national policies for surveillance of antimicrobial resistance, with the inclusion of animal data and the One Health approach.6

In 2008, the World Organization for Animal Health (OIE), the World Health Organization (WHO), and the Food and Agricultural Organization (FAO) launched the concept of "One World, One Health," in which the term "One Health" was a concept suggested to demonstrate the relationship between human, animal, and environmental health.7 One Health is an approach to designing and implementing programs, policies, legislations and research in which multiple sectors plan, communicate and work together to achieve better public health outcomes for all the sectors.8 The "approach is also required for other public health threats at the human-animal-ecosystem interface. These include food safety and security, antimicrobial resistance and emerging and re-emerging infectious diseases with consequent spillover from animals to humans and vice versa.8

As Nigeria's and other countries' food is becoming increasingly globalized, the need to improve the food safety systems between countries is clearly becoming more evident. The development of the Framework for Action on Food Safety, based on the principles of Codex Alimentarius and systems of food control, is important. It is critical for stakeholders in Nigeria to ensure the implementation of the Framework for Action on Food Safety taking into consideration the strategies, guidelines and experiences highlighted by the Global Food Safety Strategy, UN Food System Summit, and estimation of the global burden of foodborne diseases through WHO, Foodborne Disease Epidemiology Reference Group (FERG). 9 In addition, the United Nations recently stressed that intersectoral and multidisciplinary measures and a unified view of health care are critical to achieving the goals of the 2030 Agenda for Sustainable Development.10

The Federal Government of Nigeria recognizes the need to join forces across sectors and, has developed a 5-year strategic plan and a 1-year implementation plan for One Health in Nigeria (2019-2023).11 The Nigeria One Health initiative with the coordination of NCDC has the vision of creating a nation of healthy people and animals living in a balanced ecosystem. The mission is to build a strategic, dynamic and functional platform that advances human, animal and environmental health through multidisciplinary and inter-sectoral collaboration.11 This was targeted to be achieved through creating partnerships, leadership and coordination, using a skilled workforce with an emphasis on research, innovation and development. The plan was to be implemented through surveillance and response, training and research, governance and leadership, communication and resource mobilization.11

### Challenges

In the absence of a specific disease threat, examples of national commitment to One Health are increasingly difficult to find due to competing health and development priorities competing for attention and programmatic funding.12 Few public health policies comprise all pillars of the One Health approach to prevent diseases and to protect and promote health by joining efforts from different sectors through multidisciplinary collaboration and by recognizing the interdependence between the different components of the human/animal/environment triad. Minimal importance is given to the institutional, political, and social factors associated with the implementation of public policies within the One Health approach.7

#### Ways forward

It will be essential to consider the following practical steps to improve One Health in Nigeria .1

1. After action review of the Nigerian One Health strategic plan (2019-2023), this will provide an idea of what was done and what is needed to strengthen the One Health approach in Nigeria

2. Assessment of the level of implementation of the strategic plan at the state level

Curriculum guidelines should include One Health at all levels of training
Legal framework that legitimizes public health practices from the perspective of One Health;
Research support towards the implementation of One Health as a public policy; and

6. Various working groups and fora consisting of the government, private sector, and civil society to identify public health issues within the scope of One Health.
